

TERMS OF REPRODUCTION AND USE OF DOCUMENTATION (PRIVATE USE, PUBLIC USE AND/OR REPRODUCTIONS MADE BY THE REQUESTOR)

Procedure

- In the event that the application involves the reproduction of digitised, large format materials, the Exponav Foundation will choose the establishment responsible for making the reproduction.
 - It will be a simple reproduction without any post-scan digital treatment, in colour. The cost of said reproduction will be covered by the requestor. The requestor will make the payment directly to the establishment chosen by the Exponav Foundation to make the reproduction. The method of payment will be decided according to the possibilities available in each case, and after the agreement of both parties (bank transfer, direct payment through a peer-to-peer payment service, or direct payment at the establishment responsible for the reproduction).
- The aforementioned images will be sent in PDF format, via email. In those instances
 where either the number or the size of the images does not allow for them to be
 sent via email, the requestor will receive them through a large file transfer service.
- To protect the integrity and privacy of our digital images we combine two techniques: a password-based access protection and management system, and the watermarking of digital images with the Exponav Foundation trademark to explicitly state their origin and ownership.

General terms of use

- To obtain an image without the Exponav watermark, the applicant must request it
 in advance, and commit to citing the source of the images, as well as to using said
 images exclusively for the purposes stated in the application.
- The source of the images will be cited as follows: Exponav Archive Collection*
 [*to be specified when filling out the form].
- The requestor will comply with the provisions of the Intellectual Property Act, and in particular with that stated in these Terms of Use.
- As one of the organisations sharing the copyright of the images, the Exponav Foundation authorises their use for the aforementioned purposes (Request for

- Unauthorised assignment/cession/distribution to third parties, complete or partial reproduction, and transformation of the requested material is prohibited; unauthorised creation of derivative works resulting in the modification of the original material is also prohibited.

- The authorisation for the public display of the images, and in the event that said images are to be included in a publication, will grant permission for one use and one edition only, according to the conditions expressed in this procedure. For any new use or reedition, the applicant must request the corresponding authorisation sufficiently in advance, and, if necessary, renegotiate its conditions.
- If the images are to be part of a monograph, the source of said images will be stated explicitly, and the applicant undertakes to deliver to the Exponav Foundation a free copy of the publication containing the reproduced material to become part of the documentary collection of the Exponav Foundation.
